PenguFarm GAME provide an **easy to use** tried and trusted alternative to using your own recording system. Its your **all-in-one on-farm game management information system**. It was developed for easy and efficient record keeping, administration, performance testing, selection, breeding, marketing and general management. The program is specifically designed for the **needs of the South African game breeder and it caters for all aspects of game recording and management:** from purchases, matings, pregnancy tests, calvings,


horn measurements, photos, weights, pedigrees, vaccinations, diseases, injuries, treatments to sales, mortalities and camp activities. It is easy to populate the program's database with your animal data using various sources, for example data can be imported from Excel or entered easily by hand via the Add Animal Wizard.

The South African company BenguelaSoft has developed BenguFarm GAME, as well as the well-known and widely used

BenguFarm BEEF beef cattle management software package. There are also modules for sheep, goats and pigs. The various modules of BenguFarm are used by close to 800 breeders across 14 countries and 4 continents. The software is endorsed by 19 beef cattle breeding societies. All modules are developed on the same principles - if you know one, you will be able to master all the others. BenguFarm GAME was developed during the past four years using expertise from various institutions, prominent game breeders like Thaba Tholo and Tina de Jager and other individuals in the game industry. These inputs ensured that the program meets the needs of all game farmers and related institutions. The BenguelaSoft development approach is unique: user requests and suggestions are taken into account in the on-going development of the software.

The programme caters for 45 game species, including sable, roan, rhino, buffalo, nyala, impala, oryx, tssebbe, springbuck and wildebeest. Subspecies, families/bloodlines and colour variants (including "splits") can also be recorded.

BenguFarm GAME provides for **extensive data verification** to ensure that data is recorded correctly. BenguFarm GAME automatically indicates fertility of females from **various reproduction calculations** like age at first calving, inter-calving periods, days since last calving and **expected calving dates**. Production trait calculations, like **horn growth per month**, are also calculated. These upto-date scientific results enable breeders to use various **age corrected horn measurements and indices** for easy comparison and accurate selection of animals. If pedigrees are recorded, high levels of inbreeding can easily be avoided, as **inbreeding coefficients are estimated** for all animals, including progeny of planned matings.



Another unique feature of BenguFarm GAME is the **Animal Darting Data window**, where veterinary info, horn measurements, photos, camp movement, inoculations, microchip implants, pregnancy tests, fertility tests, teeth condition, manure samples (for worm egg counts), treatments for illnesses or injuries and veterinary notes (including reminders for follow up) can be recorded quickly and easily on one

window. All **veterinary info** of a specific animal is therefore always available throughout the animal's life. Animals are also linked to **camps and management groups**, so keeping track of animals is quick and easy. Animals can also be linked to **camps and management groups for quick and easy selection** of animals and to keep track of what animals are or were in a specific camp. The **camp movement history**

can, among others, be used to determine the bull(s) which may be the possible sire of a calf.

The **PhotoTape** functionality enables the user to **estimate horn and other measurements from a photograph**, without the need to dart the animal. This is done by scaling for example the horn length using an object in the photo of known size, e.g. an ear tag with a circle.



A very important aspect of game breeding (and buyer's peace of mind) is the **DNA certification of parents and bloodlines**. Parentage and bloodlines are determined by DNA analysis, using hair or other biological samples, at laboratories such as UniStel. DNA reference numbers and all certification information, such as bloodline analysis method (**nuclear or mitochondrial DNA**), issued by these laboratories are captured by BenguFarm GAME. Certified animals and parents are **identified and marked with a symbol** in all BenguFarm GAME windows and reports.

The program has more than **50 reports** and recording lists for general and health management, breeding, recorded traits (e.g. horn measurements), selection, sales, auction catalogue and herd administration. These

reports also include recording lists for easy recording while measuring. - A sale by auction is complete when the auctioneer announces its completion by the fall of the hammer, or in any other customary manner, and until that announcement is made, a bid may be retracted.
- 4) Notice must be given in advance that a sale by auction is subject to
 - a) a reserved or upset price; or
 - b) a right to bid by or on behalf of the owner or auctioneer, in which case the owner or auctioneer, or any one person on behalf of the owner or auctioneer, as the case may be, may bid at the auction.

authorizes the Auctioneer to collect the purchase price from the Buyer and the Owner / Seller do hereby cede to the Auctioneer all the Owner / Seller's rights, title and interest in and to its claim for payment of the purchase price against the purchaser, which session the Auctioneer do hereby accept.

- 7. The purchase price of the goods sold by auction specifically excludes VAT and VAT must be added to the purchase price and paid by the Buyer unless specifically indicated otherwise. Declaration and compliance related to all applicable taxes is the responsibility of the Owner/Seller and Buyer as relevant.
- 8. Risk in respect of profit and loss in the goods sold shall pass to the Buyer upon the fall of the hammer and upon acceptance of the bid by the Seller. This risk will specifically exclude mortality of the goods. The risk in mortality of the goods will remain with the Seller until the goods are loaded on the Buyer's transport. Notwithstanding the passing of risk, ownership shall remain vested in the Seller until such time as the full purchase price has been paid to the Seller.
- 9. Delivery of the goods sold at the auction, shall only be given to the Buyer upon the Buyer fully performing its payment obligations in accordance with these conditions of sale. The Owner / Seller shall be responsible for costs incurred to deliver the goods on the Buyer's transport. The Buyer shall be responsible for procuring and paying for transport of the goods from the Owner / Seller's property.
- 10. The parties specifically agree that no bid may be retracted after the bid has been knocked down (fall of the hammer) and accepted by the Owner / Seller, unless the Owner / Seller consents thereto in writing.
- 11. Subject to any reserve price placed on any of the goods by the Owner / Seller, and the provisions of clause 12 and 13 below, the Buyer at any sale by auction shall be the highest bidder indicated by the auctioneer by the fall of the hammer or by such other means as the auctioneer may select.
- 12. The auction shall take place under the direct and exclusive control of the auctioneer. The auctioneer reserves the right, in its sole discretion, to refuse the bid of any person, to regulate the bidding and to indicate the highest bidder. If the auctioneer suspects that a bidder has not made a bona fide bid, or is unable to pay the purchase price or has not made satisfactory arrangements for payment of the purchase price, he may refuse to accept the bid of such bidder or accept it provisionally until the bidder has satisfied him that he is in a position to pay the purchase price or that he has made satisfactory arrangements for payment thereof. On refusal of a bid under such circumstances the goods may immediately be re-auctioned.
- 13. In the event of a dispute arising amongst the bidders and / or the Auctioneer, the goods in dispute shall, at the sole discretion of the Auctioneer, be re-auctioned.
- 14. Any error by the auctioneer shall be entitled to be corrected by him or her immediately upon discovery.
- 15. Should any contractor remove any goods from the sale venue on instruction of the Auctioneer, acting on behalf of the Buyer, the contractor will be deemed to be the contractor of the Buyer who accepts all costs and risks connected with such removal.
- 16. The Owner / Seller warrants that there are no encumbrances on such goods, that the said goods are the property of the Owner / Seller, and that the Owner / Seller is competent and legally entitled to dispose of the goods.
- 17. The Owner / Seller, who offers the goods for sale, accepts all liability regarding the information furnished as to pedigrees, ages, dates of service, state of health or gestation or any other particulars which might be incorrect. In the event of any dispute the Buyer shall only have a claim against the Owner / Seller and not against the Auctioneer. The Owner / Seller and Buyer indemnify the Auctioneer against any claim(s) regarding the information furnished as to pedigrees, ages, dates of service, state of health or gestation or any other particulars which might be incorrect.
- 18. Should any animal be sold as pregnant, pregnancy will be confirmed upon capture for loading costs of which are for the Owner's/Seller's account. The Buyer or his representative is advised to be present to witness confirmation of pregnancy. Should the Buyer or his representative not be present, the veterinarian's report confirming pregnancy will be taken as final. Furthermore, where an animal is sold as pregnant, pregnancy upon loading is guaranteed, but no calf or lamb is guaranteed. Once safely loaded onto the Buyer's transport, the risk of the animal's pregnancy transfers to the Buyer.
- 19. Where goods are put up for auction the following conditions apply to such goods:
- 19.1 Where the age of the animals are not specified, will the animal be regarded to be in a good and healthy condition.
- 19.2 All animals put up for auction must, where applicable, must be visibly marked with ear tags and/or microchips.
- 19.3 Where available, DNA information of the animals must be provided to the Auctioneer in order for the Auctioneer to include such information in the Auction Catalogue.
- In the event where the photos and specifications are not animal specific; the buyer has the right to choose a similar animal, as described, from the herd concerned, and presented in the Auction Catalogue.
- In the event where the Client acted bona fide and the animals put up for auction did not meet the specifications as described in the Auction Catalogue (i.e. pregnancy, age horn length, etc.), the buyer has the right to cancel the transaction or to negotiate new terms and conditions. The commission shall be payable on the new terms as agreed upon between the Owner/Seller and Buyer and approved by the Auctioneer.
- 19.6 Horn lengths provided by the Client or its duly authorised representative, of animals put up for auction, are warranted by the Client.
- 20. All delayed deliveries due to an additional pregnancy is at the Buyer's risk, including calves. The period required for an animal to be certified pregnant will

- be determined by the Seller. The Buyer is advised to take out insurance cover on animals remaining on the Seller(s) farms where risk has passed to the Buyer.
- 21. The Owner / Seller warrants that the goods sold are free of any known patent and latent defects and that any right or claim ceded to the Auctioneer in terms of these Rules of Auction is free of any defect or right of deduction or set-off, and that the said right or claim is fully and immediately enforceable against the Buyer.
- 22. The Buyer shall, prior to the sale, ascertain whether there are any defects in the goods and any bid by a Buyer shall be considered as acceptance of the goods with any patent or latent defects in their condition at the time of sale.
- 23. The Buyer shall not be entitled to withhold payment of the purchase price to the Auctioneer as a result of any possible or pending claim that he may have against the Owner / Seller on the grounds of misrepresentation or for any other reason whatsoever.
- 24. The purchase price is payable by the Buyer to the Auctioneer via electronic transfer ("EFT") on the date of sale ("the payment date") unless other payment terms and or means are agreed between the Auctioneer and the Buyer. The Auctioneer reserves the right to refuse any other method or means as payment. Payment by way of EFT will only be regarded as done as soon as the funds transferred reflects and are available in the Auctioneer's bank account.
- 25. In the event that the Auctioneer agrees to facilitate the purchase of the goods by paying an amount equal to the purchase price to the Owner / Seller before the Buyer makes payment to the Auctioneer ("the Payment Terms Agreement"), then the following shall apply:
- 25.1 The election to make any payment to the Owner / Seller shall be in the sole and absolute discretion of the Auctioneer, which discretion may be exercised separately with regard to each transaction entered into by the Buyer.
- Upon payment of the amount referred to in 25.1 above the Owner / Seller's right, title and interest in and to any claims and other rights against the Buyer in terms of or connected with the sale of the goods shall forthwith be ceded and transferred to the Auctioneer, which session the Auctioneer hereby accepts.
- 26. In the event of any Payment Terms Agreement between the Auctioneer and the Buyer, the following shall apply;
- 26.1 No Payment Terms Agreement shall be valid unless reduced to writing and duly signed on behalf of the Auctioneer. The facilitation of any sale by the Auctioneer as referred to in this paragraph 25 shall be strictly subject to the terms and conditions of the Payment Terms Agreement.
- In the event of any conflict between the contents of this document and the Payment Terms Agreement, the provisions of the Payment Terms Agreement shall prevail.
- No application for credit as defined in section 8 of the National Credit Act, Act 34 of 2005, will be received or considered by the Auctioneer.
- 27. Anyone that intends to bid at the auction (Buyer) must register his or her identity on the bidder's record prior to the commencement of the auction and such registration must meet the requirements of the FICA (Financial Intelligence Centre Act, 2001) in respect of the establishment and verification of identity of the person. The prospective Buyer must sign the registration entry and furnish the Auctioneer with a copy of his/her identity document and proof of residence (not older than 3 months).
- 28. Any person who purchases on behalf of a Principal (i.e. natural person) must furnish the Auctioneer with a written signed Power of Attorney, prior to the commencement of the auction, failing which he/she will be personally liable for payment of any purchases made by him/her. The person bidding on behalf of or signing any document on behalf of the purchaser pursuant to a successful bid hereby binds himself/herself personally as co-principal debtor with the Buyer for payment of the purchase price and personally guarantees all the obligations of the Buyer under these Rules of Auction.
- 29. A person who attends the auction, to bid and to sign the bidder's record, on behalf of another person (i.e. on behalf of a company or legal entity) must produce a signed letter of authority that expressly authorizes him or her to bid or sign the bidder's record on behalf of that person. Where a person is bidding on behalf of another entity the letter of authority must appear on the letterhead of the entity and must be accompanied by a certified copy of the resolution, if required, authorizing him or her to bid on behalf of the entity. The person bidding on behalf of or signing any document on behalf of the Buyer pursuant to a successful bid hereby binds himself personally as co-principal debtor with the Buyer for payment of the purchase price and personally guarantees all the obligations of the Buyer under these Rules of Auction.
- 30. In the event where a Buyer allows another person to purchase on his or her Buyer's number, the registered Buyer shall be liable for payment of such purchases. No bid by an unregistered Buyer will be accepted by the Auctioneer and the Buyer will have no claim to any of the goods allegedly purchased by him.
- 31. Until all amounts owing by the Buyer have been paid in full, the Buyer hereby:
- 31.1 irrevocably undertake to identify the purchased goods in such a manner that he can at any time identify and indicate the goods deemed to be the property of, and pledged to, the Auctioneer.
- grants the Auctioneer at all reasonable times access to the premises where the goods are stored or kept for the purposes of perfecting its pledge and exercising any other rights in terms of these Rules of Auction.

- 32. The Owner / Seller, Buyer and Auctioneer herewith confirm that any action instituted by the Auctioneer against the Owner / Seller and / or Buyer may be instituted in any competent Court. This agreement will be governed in accordance with the laws of the Republic of South Africa.
- 33. A certificate issued by a Manager of the Auctioneer, whose appointment and authority shall not be necessary to prove, shall be prima facie proof of the amount owing by the Buyer to the Owner / Seller or the Auctioneer.
- Any indulgence granted by the Auctioneer to the Buyer or the Owner / Seller will not prejudice the rights of the Auctioneer in terms of these Rules of Auction and such indulgence will not constitute an amendment or waiver or novation of these Rules of Auction.
- 35. The entries made in the Auctioneer's auction roll shall be prima facie evidence of the transaction and shall be binding on the Owner / Seller and the Buyer.
- 36. The bidder's record and the vendor or vendu roll will be made available for inspection within reasonable time after the auction at the office of the Auctioneer during normal business hours free of charge.
- 37. All money will be paid into a trust account for the benefit of the Owner / Seller, minus the agreed commission and additional costs agreed upon by and between the Auctioneer and Owner / Seller.
- Any goods entered or offered for sale are subject to payment by the Owner / Seller / Buyer of the agreed commission, or in absence of an agreement the usual commission by the Owner / Seller / Buyer to the Auctioneer at the rate customarily charged by the Auctioneer from time to time, whether the goods are sold at the auction or thereafter, or within 30 days thereafter by private treaty. Unless otherwise agreed in writing, commission shall become due and payable by the Owner / Seller/ Buyer upon the fall of the hammer or upon the entering into of any private treaty involving the Owner / Seller's said goods, whichever date is the earlier, and notwithstanding any breach on the part of the Owner / Seller/ Buyer.
- 39. Every bid shall constitute an offer to purchase the property or goods for the amount bid, which the Owner / Seller or the Auctioneer may accept or reject in their absolute discretion. The Owner / Seller and Auctioneer are entitled, in their absolute discretion to withdraw the property or goods from the sale prior to acceptance by the Owner / Seller.
- 40. If no bid equals or exceeds the reserve price, if any, the property or goods may be withdrawn from the auction.
- 41. The Auctioneer accepts no liability for any withdrawal of goods from sale.
- 42. The Buyer will be responsible to obtain all permits, certificates and transport documents pertaining to the game purchased at the auction. The Buyer will be liable for the payment of the purchase price even if he is unsuccessful in obtaining the required permits, certificates or transport documents. As such it is specifically stated that no sale on the auction is subject to the Buyer's successful application for any permit, certificate or transport document.
- 43. No bid may be withdrawn after the fall of the hammer until the expiry of the confirmation period (if any) that is provided for in the Conditions of Sale, during which time the offer shall be open for acceptance by the Owner / Seller or his agent and if the offer is accepted the sale shall be deemed to be a sale by auction for purposes of the Act.
- 44. In the event of the sale requiring the consent of any statutory authority or any court of law, then this auction will be subject to the granting of such consent.
- 45. The Buyer and the Owner / Seller do hereby consent to the payment of attorney and own client costs in the event of any legal action being instituted against them by the Auctioneer or Owner / Seller.
- 46. Any agreement contrary to these Rules of Auction shall not be binding unless it is confirmed in writing and signed by a manager of the Auctioneer.
- 47. If any clause or term of these Rules of Auction should be invalid, unenforceable and illegal, then the remaining terms and provisions of these Rules of Auction shall be deemed to be severable there from and shall continue in full force and effect unless such invalidity, unenforceable or illegality goes to the root of these Rules of Auction.
- 48. Default by Buyer: Should the Buyer/Purchaser refuse or otherwise fail to pay the purchase price within 7 days of the due date, the Auctioneer shall be entitled to;
- 48.1 claim interest from the Buyer/Purchaser the prescribed mora interest rate calculated from the date of purchase to date of payment, and/or
- 48.2 repossess the goods to resell same at the risk of the defaulting Buyer/Purchaser who shall be liable for all costs in connection with the resale and any loss or damage incurred, and will not be entitled to any profit that may arise from the resale, and/or
- 48.3 institute legal proceedings for the payment of any amount owing or for the return of the goods in which event the provisions of clause 48.2 will apply,
- 48.4 recover the Auctioneer's legal costs calculated at the Attorney and own Client tariff as well as collection, tracing, storage and transport costs, and
- retain in pledge any goods or other property in the possession of the Auctioneer belonging to either the Buyer / Purchaser or the Owner / Seller as security for the due fulfilment of any obligation owed to the relevant party or the Auctioneer.
- 49. Any dispute between the parties will be governed by the South African legal system and legislation.
- 50. The Auctioneer reserves the right to amend these Rules of Auction in writing. By entering a bid any prospective Buyer binds himself or herself to these Rules of Auction, as well as any special conditions of sale set forth in the auction catalogue.











Background

Fascinated with all aspects of the game industry Tina de Jager established Bushveld Game Capture in 2009. The capturing of game (she realized through her own experience of game ranching started in 2005) was a lot more than pairing a veterinarian and a pilot in a helicopter and sending them off to wildlife ranchers. Tina de Jager saw a need, an opportunity and started the business. The rest is history and we at Bushveld Game Capture have since developed into a corporate business with 9 helicopters serving the game industry in all provinces of South Africa and beyond.

Our Philosophy

At Bushveld Game Capture we have a threefold approach in order to safely capture, dart and manage private as well as corporate game. We do this professionally and with integrity. We feel equal responsibility towards the handling of game, the satisfaction of our clients and our safety standards.

Game

Bushveld Game Capture has strict rules regarding the treatment of game. Working with game is at the heart of our business and our pilots understand the necessity to treat each animal with respect. We regard the minimization of stress and maximization of the welfare of each animal as a responsibility of our pilots, this they understand and apply. These rules are discussed and improved every 6 months at our Safety Seminar where veterinarians lecture our pilots on new and improved methods concerning the welfare of game.

Clients

Integrity is an important part of our philosophy at Bushveld Game Capture. Clients/owners are not often available when our flying operations take place. Depending on circumstances estimating the time for a particular capture is not always possible. After contracting us to do a capture receiving our account is often the only other contact we have with the client/owner. For this reason we have installed satellite tracking on all of our helicopters to monitor flying times and routes. This information is available to all of our clients, it is important for us to gain a clients trust in the treatment of their animals and satisfaction in terms of the work we have done for them.

Safety

The aviation side of game capture is governed by the South African Civil Aviation Authority (SACCA). Laws have been instituted to determine minimum standards to be adhered to by all commercial helicopter operators. Although sometimes misunderstood, the officials attempt to hold operators to a set of rules that will keep pilots, passengers and helicopters flying safely. Being such a complex industry operating in distant parts of the country it is very easy to find loopholes and shortcuts to keep SACAA satisfied. Flying with helicopters that are not 100% airworthy and pilots breaking rules will often go unnoticed. Combining the dangerous environment that pilots fly in 'unsupervised' operations can lead to accidents. Bushveld Game Capture finds this unacceptable. Proper risk analysis has brought Bushveld to a point where we demand higher standards from ourselves than those required by minimum legal standards. We combine this with a safety program to monitor the performance of our pilots. The 'fleet renewals' program is part of our safety philosophy as we renew helicopters every 1000 hours in order to supply a reliable and safe service tour for clients. Often entrusted with passengers we carry insurance in the event of unforeseen incidents.

Every six months we ask our clients to bear without our services for 3 days in order to hold a Safety Seminar. Here pilots are lectured by doctors, veterinarians and other specialists, their flying skills are tested and improved. Bushveld Game Capture has a zero tolerance attitude towards all personnel and this has given us the confidence to service any veterinarian and game farmer in South Africa professionally.

The love of game and the intrigue of aviation make game capture unique and demanding. Operating with integrity in a strict, professional and safe environment is what we are all about at Bushveld Game Capture and service for clients is available 365 days a year.
